08. Brief Description of the Organization.

The MHCD Society is open to the Disabled Children of the Monaragala District irrespective of cast, religion, race or economic status of the society. The doors of this

society are open not only for the children who are Mentally Impaired but also for the other Disabilities and for the aged who have no one to look after them at their old age when they are being isolated as they are more still unwanted by the wide world and also by their kith and kin due to the lack of education. The aim of the society is to protect these children from discrimination they may face and to explore the hidden potentials and develop them by a qualified and dedicated staff with loving care and affection. We are delighted to state that we initiated with 9 children and at present we are having 70 residents. Among the Intellectually impaired majority are Down's and some are having physical disabilities.

09. Objectives of the organization:

Our main objective is to provide solace and security to the intellectually impaired Persons with Special Needs who grow old and aged. Most of the children in home are being either given by the Court of Law, Children who have lost their kith and kin by the Tsunami Disaster, by the Probation Office and by the Social Services Departments of the Uva Province. These children once they grow old and feeble as they do not have any one to look after them. They depend on our security till their last breath. Hence we are responsible to provide their entire dire needs.

The main aim is to upgrade the living standard of the residents and to make their lives comfortable and to create the best person hidden within them by providing all the necessary therapeutic interventions to minimize the impact of disabilities and to bring them back to the maximum functional level. According to the objective assessment of each individual we have been providing them medical, paramedical, educational facilities and refer to the appropriate relevant streams aiming at a complete rehabilitation.

Provide vocational training according to the abilities and desires to improve the skills for their future lively hood support. Provision of accessibility facilities for easy access to all to move freely in the home environment. Together we campaign to bring the voices and opinions of Persons with Special Needs to the attention of policy makers and to put disability at the heart of national and international development programs for the removal of barriers which hinder them. The aim of the society is to protect these special children from the child abuse and to promote advocacy and campaign program to stand together for their rights and to live happily as equal citizens without discrimination.

13. Brief Description of the Project:

At present we are having more than 60 permanent residents, 15 staff members. We all have to bathe in the morning and evening. Further we use water for cooking, clearing the 13 toilets, dormitories, drainages etc.

The alms givers use to visit the centre in groups and they too consume water. After the provision of meals water is necessary for washing plates, cup etc. In absence of alms giving we use water for washing, cooking and for cleaning the huge vessels. Since we conduct vocational training for our special children we consume water for watering the vegetable plots and for cultivation other types of vegetables and banana plants etc.

Since our staff members have flower vases and other types of flowers there is a dire need to water them daily to keep them alive for beauty.

We celebrate special occasions graciously annually and there are about five to six special occasions and the average of participants exceeds 300.

Monthly wise we conduct D. P. O. meetings, committee meetings and so on. There are some such special occasions where we need an extraordinary volume of water.

14. Contribution from the organization:

We are having a tube well 40 meters of depth. We have already settle down water pumps and pipe line to the needed areas.
