Sith sewana is an intellectually impaired center for special children which is located in thanamalvila in monaragala District which was initiated in the year 1999 with 9 children and at present we are having 70 including staff members the total figure is about 85.

We are having about 15 children, youths, adult males and females who are not having bladder and bowel control. Hence they might pass stools and urine at any unexpected time during the Course of the day and night. Perhaps they might pass several times and we have to change the costumes several times and throw them away.

Majority of our children were sent by courts, probation offices and services Departments in Uva province since this is the unique reputed and recognized health and rehabilitation Centre in Uva province. Perhaps the Government authorities contribute only Rs. 50/= per head.

Most of our special Children have neither kith and king nor guardians and they have to be under our security till their last breath. Hence we are responsible to provide them their entire dire needs.

Though we are receiving regular alms giving perhaps most if the days we have to prepare the breakfast for our special Children. Further in several occasions even fixed lunches and dinners within the month are being cancelled due to urgent unavoidable circumstances and incidents of the alms givers.
